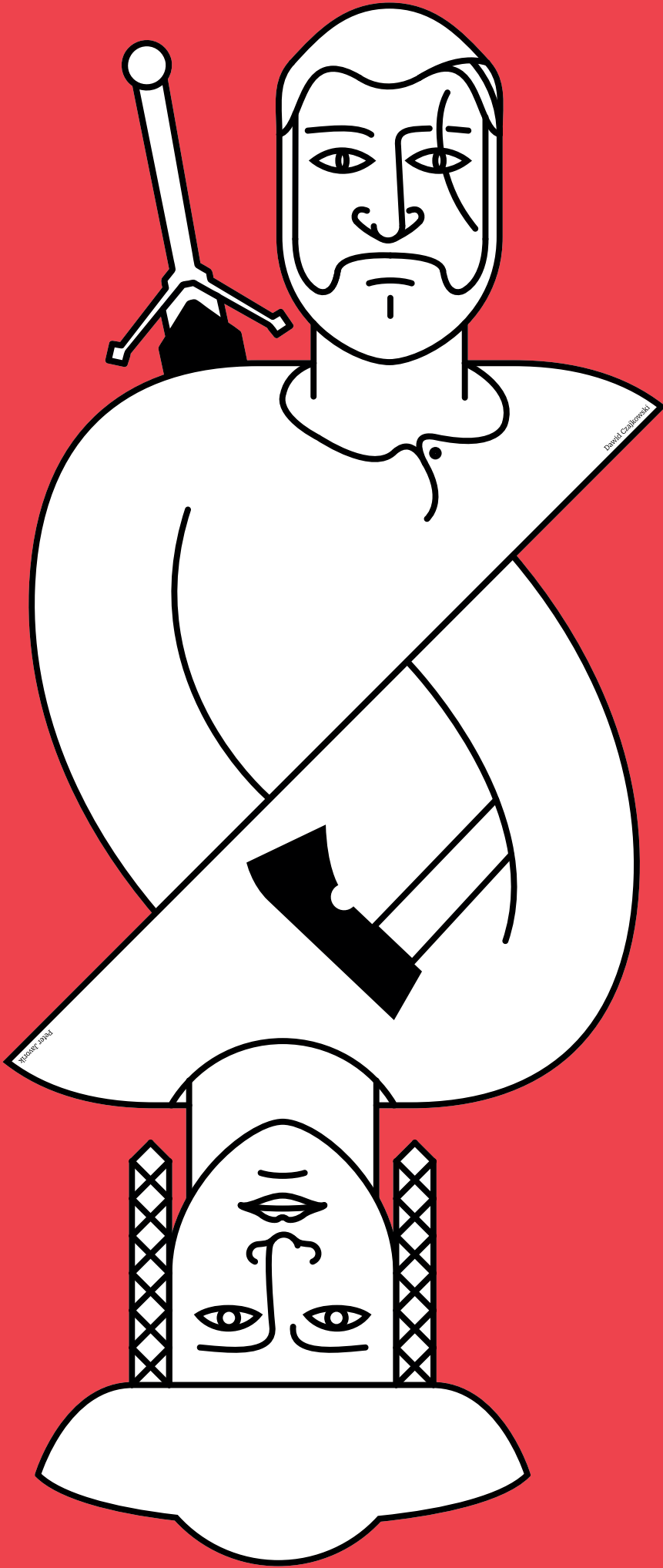

Submissions are free fee for all. Worldwide Graphic Designers members and non-WGD members can participate!

Completed works, after pre-selection and main selection, will be presented in the capital of Indonesia, Jakarta, in Tangerang at the Summarecon Mall Serpong Gallery (long list, main exhibition). Then, after third selection, posters will go to Szczecin, Poland to Gallery Guillotine to be part of Super-Hero Exhibition of the 25 best posters (shortlist), where it will be installed and organized by WGD vice-president Dawid Czajkowski, founder and curator of Guillotine Gallery, at a specially designed exhibition in the legendary Kana Cellar.

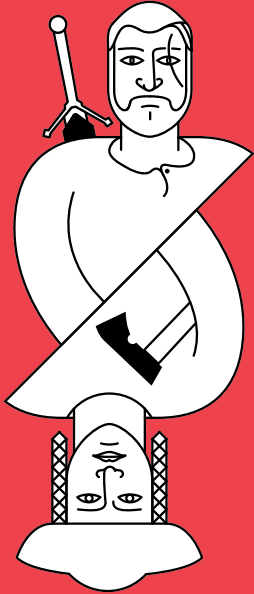

Information clause regarding the consent to process personal data.

1. The Administrator of your personal data will be Irwan Harnoko, Worldwide Graphic Designers, Gallery Guillotine, Fundacja Instytucja, Dawid Czajkowski and Mateusz Chojnacki.
2. Personal data will be processed in order to hold the competition and for promotional purposes.

Processing of personal data is based on the consent of the person who is the data's subject (based on article 6 (1) (a) RODO).

3. Your data will be processed based on the provisions of law, for the period of time necessary to achieve the objectives listed in clause 2, and not less than the period specified in the archiving provisions.
4. You are entitled to:
 - access your data, based on art. 15 of RODO, provided that shared data cannot reveal undisclosed information, neither infringe legally protected information, to which protection the Administrator is obliged
 - rectify your data, based on art.16 of RODO
 - limit your data processing, based on art. 18 of RODO
 - transfer your data
 - withdraw your consent to processing of your personal data, without affecting the lawfulness of its processing based on the consent before its withdrawal
5. Providing your personal data, such as: name, surname, e-mail address is voluntary, but simultaneously required to take part in the Competition
6. If you believe that the processing of your personal data by the Administrator violates the provisions of the RODO clause [GDPR], you have the right to lodge a complaint with the supervisory body (the President of the Office for the Protection of Personal Data).

Copyrights:

ownership of the competition work:

1. Entering the Competition is synonymous to granting the Organizer a free of charge, non-exclusive license to use the competition works, in need to: organize the Competition, announce the results of the Competition, hold and exhibition of the competition works, present the competition works on the Internet, release an after-competition catalogue, and to promote the Competition and the We Are SuperHero International Poster Exhibition.
2. A Participant grants the license for an indefinite period of time, within an unlimited territory, for: putting the works into the computer memory in order to prepare them to public dissemination, including: public display, public replaying, broadcasting and retransmitting via unrestricted range of devices, systems and standards, as well as granting public access to the Competition Works at the time and place of one's choosing; via wired and wireless Internet.
3. The Participant declares the Competition Work to be an outcome of his individual creative working process of unique character, and states that it does not infringe the rights of third parties. In case of third parties raising any claims against the Organizer, through a lawsuit regarding copyright infringement applying to the Competition Work, due to the Organizer's using the license, the Participant is obliged to join the court case on the side of the Organizer and exempt the Organizer from any claims, likewise meet the adjudged claims of the claimant, along with other costs.
4. The Organizer is entitled to disqualify the Participant and remove their competition works from the competition presentations, in case of suspicion of plagiarism or violating any other regulations.

Final Provisions:

1. This Regulation is the only document defining the rules of the Competition.
2. Submitting your works into the Competition is synonymous to accepting of the listed rules, which final interpretation is at the discretion of the Organizer.
3. This Regulation is available for the reference of the participants on the etnokrakow.pl and rozstaje.pl websites.
